Final clear out will take place with the Chief of the group and a representative of HUBERTUS GROUP on the last day of the hunt, after the protocols signing.

The Chief of the group pledges to pay for himself/herself and the group according to the offer and for the game shot during the hunt. The payment for the game shall be done in cash on the last day of the hunt. In some cases HUBERTUS GROUP may accept the money transfer after the hunt, if so, the amount to be transferred will be written down and presented to the hunter and must be accepted by the hunter by his/her signature. The Chief of the group confirms that the conditions of the hunt and payment have been presented to him/her by HUBERTUS GROUP and that he/she knows and accepts the offer he/she books and so does the group.

General conditions of the sale of hunting trips arranged by HUBERTUS GROUP

GENERAL INFORMATION

1. All correspondence concerning services provided by HUBERTUS GROUP (request for our offer or price list to be sent, booking hunting trips, ordering additional services, remarks and complaints relating to customer's stay) shall be sent to the HUBERTUS GROUP address:

2. All orders and bookings shall be made on the "Booking Form", which each time shall be enclosed with the offer, which HUBERTUS GROUP sends the customer. The Form should be filled in carefully and legibly and signed by the contracting party. Bookings made in any other fashion shall not be realized.
3. Bookings may be made by:
 - any individual customer,
 - an individual hunter who is the hunting team leader and on behalf of the whole team.In the upper case the team authorizes its leader to conclude a contract with HUBERTUS GROUP on behalf of all people participating in the hunt being booked.

OFFER AND CONTRACT

1. The offer which HUBERTUS GROUP sends the customer shall include the following information:
 - a general description of the hunting ground offered,
 - the manner of hunting,
 - the offered number of game earmarked for shooting, whereas HUBERTUS GROUP hereby warns that, in the case of hunts according to the price list, the specified numbers of game do not constitute the HUBERTUS GROUP guarantee as to the hunt's results,
 - in the case of hunts at a flat-rate cost, the guaranteed number of game earmarked for shooting,
 - a description of accommodation,
 - a suggested date of hunt,
 - the cost of stay during the hunt,
 - in the case of hunts according to the price list, the manner of paying for the game shot,
 - the date of making as well as the amount of the advance payment.
2. The contract shall be concluded each time after the customer has signed a filled-in "Hunting Trips Booking Form / Contract" and sent it to HUBERTUS GROUP, HUBERTUS GROUP received the application, and the customer made an advance payment.
3. After the customer has sent the filled-in "Hunting Trips Booking Form / Contract" and made the prescribed advance payment, he/she shall receive a written confirmation of the hunting trip's acceptance from HUBERTUS GROUP.
4. After HUBERTUS GROUP has received the advance payment, it shall be obliged to issue and send to the customer a Voucher, which shall be made out using the data provided by the customer on the "Hunting Trips Booking Form". This Voucher, along with the customer's ID or passport and a European Gun Permit, shall constitute the grounds for a permit to bring hunting arms into Poland. However, the above-mentioned refers only to EU citizens. Hunters from outside the EU should also visit their local Consulate of the Republic of Poland bringing the Voucher along and request a permit to bring arms into Poland. Each hunter shall be obliged to carry these documents at all times during their stay in Poland and present them on request from proper authorities.
5. Any and all amendments made after the booking has been accepted, either by the customer or HUBERTUS GROUP, shall be made in writing.
6. HUBERTUS GROUP reserves itself the right to amend the contract due to reasons beyond HUBERTUS GROUP control or the number of participants differs from the minimum required by HUBERTUS GROUP and specified in the offer.
7. HUBERTUS GROUP reserves itself the right to cancel the hunting trip up to 14 days prior to its commencement, or any time due to reasons beyond the organizer's control.

PAYMENT CONDITIONS

1. The prices of HUBERTUS GROUP services are contractual prices and include the VAT.
2. At concluding the contract, the customer shall be obliged to make an advance payment prescribed by HUBERTUS GROUP.
3. The remaining cost of the stay during the hunting trip (accommodation and food, preparation of the hunting ground, organization of the hunt, a beater or a beat with hounds, preparation and evaluation of trophies, Polish liability insurance, an interpreter, administrative fees, the voucher) should necessarily be paid prior to the hunt, but not later than 40 days before the planned commencement of the hunt, unless HUBERTUS GROUP grants another deadline for the payment of the full amount due. Default on these obligations shall be treated equally to withdrawing from the contract pursuant to the conditions provided for in Article titled "Resignation from the Hunting Trip".
4. As for the conditions and form of payment for the game shot and trophies, these shall be estimated each time and sent to the customer in the offer.
5. HUBERTUS GROUP reserves itself the right to demand advance payment for game earmarked for shooting before the commencement of the hunt.
6. Any and all advance payment for game earmarked for shooting received prior to the hunt shall be settled following the hunt and when the hunt protocol has been signed. In case the advance payment exceeds the price of the game shot due to HUBERTUS GROUP, the complete excessive amount shall be paid back to the customer.
7. Any and all settlements between HUBERTUS GROUP and its customers shall be made in EURO. Payments can be made by money transfer into the following account:

HUBERTUS GROUP does not honor payment cards or cheques.

8. HUBERTUS GROUP reserves itself the right to change the prices of the hunting trip in cases of emergency, such as an increase in transport costs or official fees or taxes. In the period beginning on the twentieth day prior to the hunt, the price stipulated in the contract shall not be raised.

THE HUNT PROTOCOL

1. The grounds for a financial settlement of the hunt shall be the hunt protocol.
2. The protocol, drawn up on a proper form, shall be numbered and shall specify the type and number of the game shot, the sizes of trophies, the date of stay, the number of hunting days.
3. The protocol shall be drawn up after the hunt and the trophies evaluation, in the presence of the customer, by a committee composed of one representative of the local Hunting Club and one of HUBERTUS GROUP, in the Polish language and a language familiar to the customer.
4. The protocol shall be the grounds pursuant to which the trophies may be taken out of Poland.

5. Trophies evaluation shall be conducted 24 hours after they have been prepared. If the customer wishes to leave earlier, the evaluation shall be conducted immediately before his departure. The trophies' weight specified during the evaluation shall constitute the grounds for payment for the trophies and shall not be subject to complaint.
6. Apart from the trophies, the customer shall have the option, for additional payment and with consent from the local Hunting Club, to take out from Poland the skin or meat of the game shot, on the condition that this fact has been recorded in the hunting protocol.
7. The customer in the protocol shall make any and all remarks and observations concerning the hunt before it has been signed.

RESIGNATION FROM THE HUNTING TRIP

1. Resignation from the hunting trip may only be in writing. The resignation date shall be held to mean the date of the reception of the resignation by HUBERTUS GROUP.
2. If HUBERTUS GROUP changes, in a significant manner, the conditions of the contract, the customer shall be entitled to dissolve the contract without incurring further costs. In such a case, or in the case when HUBERTUS GROUP is forced to cancel the hunting trip, the customer shall be entitled to a full refund of the sum already paid on account of the contract.
3. In the event of resigning from the hunting trip the costs charged upon the customer shall be the following:
 - a handling fee of € 20 per person in the case of resigning 30 days prior to the starting date of the trip,
 - 25% of the trip's costs in the case of resigning 29-21 days prior to the starting date of the trip,
 - 50% of the trip's costs in the case of resigning 20-14 days prior to the starting date of the trip,
 - 75% of the trip's costs in the case of resigning 13-7 days prior to the starting date of the trip,
 - 100% of the trip's costs in the case of resigning 6-0 days prior to the starting date of the trip.

The trip's costs shall be held to mean here the costs of stay during the hunting trip according to HUBERTUS GROUP current price list.

4. The customer shall not be charged with any costs due to withdrawing from the contract if he proposes another person that shall meet the participation requirements and upon whom he shall transfer his rights and who shall take over the responsibilities arising there from.

CUSTOMER'S INSURANCE

1. During the customer's stay at the hunting trip, HUBERTUS GROUP shall provide him with the Polish liability insurance.

PERFORMANCE OF CONTRACT AND COMPLAINTS

1. HUBERTUS GROUP is liable to the customer for thorough preparation of the hunting trip and thorough performance of duties arising from the contact.
2. In exceptional cases HUBERTUS GROUP reserves itself the possibility and right to change the hunting ground and the lodgings into equal standard lodgings, or in the event of lack of such, into lower standard lodgings with simultaneous refund of the price discrepancy. However, if HUBERTUS GROUP changes the lodgings into ones of a standard higher than specified in the contract, the customer shall not be charged any further costs in respect of this.
3. HUBERTUS GROUP shall not be liable for shortcomings of the hunting trip arising from reasons beyond its control (e.g. atmospheric conditions, decisions of the State Authorities, force majeure) as well as shortcomings caused by the participants.
4. HUBERTUS GROUP shall not be liable for losses arising from public transport delays, public transport timetable amendments, loss of luggage, money, precious belongings, arms, or for accidents, as well as for any other causes beyond the control of HUBERTUS GROUP.
5. HUBERTUS GROUP shall not be liable for changes to the trip's program arising from the customer arriving late.
6. During foreign hunters' stay at a hunt in Poland, the provisions of the Polish Hunting Law apply. A representative of the local Hunting Club shall present these provisions to the hunters in a language familiar to them, prior to the commencement of the hunt.

In the event of violation of the law, particularly of violation of hunting safety regulations, the organizer of the hunt (the Hunting Club) shall have the right to exclude a hunter from the hunt, or even, in the case of a driven hunt, to cancel the hunt. In such cases HUBERTUS GROUP shall not be liable in any fashion for the organizer's decisions and shall not pay damages in respect of this.

7. The customer shall be obliged to make amends for the damage caused by himself or by any persons in his custody.
8. The grounds for considering a complaint shall be:
 - the fact of reporting to the tour guide immediately after the subject of complaint occurs so that it can be eliminated as soon as possible,
 - if the subject of complaint has not been eliminated, it shall be required that remarks in writing should be made in the hunt protocol,
 - any and all complaints shall be filed in writing within 7 days since the hunting trip's finishing date,
 - HUBERTUS GROUP shall be obliged to consider a complaint within 30 days and to reply in writing.

FINAL PROVISIONS

1. In matters not regulated herein relevant provisions of the Polish Civil Code and Tourist Services Act of 29 August 1997 shall apply.
